# The challenge

Premier España handles a large volume of property purchase contracts on a daily basis, which represents many hours of work for the people who draw them up and for the other people involved in the process. The completion of a contract includes:

**1. Processing** in a **Word file**.

**2. Review** by all parties involved.

3. Printing.

**4. Send it** to the commercial offices.

**5.** Once signed, **send them back** to the head office for scanning.

**6. Archive** the contract in the customer folder.

For these reasons Premier España had to find a tool to streamline these procedures, additionally and very importantly to **digitize the signing of contracts, which would be a big step to save printing, transferring the contract and scanning them**. 
### **Results**
